11/09 **PLANNING MATTERS**

1. To consider planning applications received:

8.10pm Cllr RS Martin left the meeting before the following item was discussed.

1.1 09/00274/OUT Archer & Archer, Land Adjacent 19 Cannon Street, Lt Downham – Outline application detached one and a half storey 3 bed chalet bungalow

RESOLVED: *Little Downham Parish Council has concerns about this application and recommends outright refusal for the following reasons:*

1. Cramped Development – *It is considered that the proposed development will result in a cramped appearance of the site and an overdevelopment of the area.*

2. Change of use of agricultural land – *It is considered that an application of change of use of agricultural land should also be applied for.*

3. No visibility splays and road safety – *No visibility splays are proposed to assist in safe exit from the site and that of No. 19. Contrary to Clause 4.3 of the Design and Access Statement, Cannon Street is considered to have more than 'relatively modest traffic flow'. It is an alternative route for drivers of general vehicles, buses and large farm machinery who want to*

avoid the congestion of the school, narrow road sections and parked cars on Main Street.
4. Parking Concerns - *The proposed tandem parking spaces on the two sites will result in added vehicle movements. The Parish Council has recently expressed concern to David Archer (Executive Director – Development Services) regarding the lack of adequate parking provision on new developments in Little Downham, which results in causing disharmony with local residents and has a detrimental affect on the local area.*

8.23pm Cllr RS Martin was invited back to the meeting.

1.2 09/00275/FUL Ms M Ranken, Plot 1 Land to the rear of 45 Main Street, Lt Downham – Construction of 2 no. semi detached two bedroom ECO dwellings – Some members had concerns and were unsure of the proposal.

RESOLVED: To defer decision until after a site visit to be held on 15/05/09 at 9.30am and the Clerk to request an extension of the consultation deadline to 29/05/09.
